## **MINDISM**

## Part 1

## Mindism is a doctrine,

not so different from Buddhism, however it does have a distinct and firm mathematical foundation, unlike any other doctrines, religions and beliefs systems. It also differs from convention, in that the information and statements I make, apply not only to this planet but extend out into the entire Universe.

It is a synthesis of information presented by some of the greatest minds of the past couple of millennia or so. My personal input is minimal but significant, in that it introduces the mechanism that connects Mind to Matter, I have not, to date, encountered this explanation anywhere else in my research.

This work explains how mind underlies all forms of life. it is a combination of math, science and philosophy, incorporating and synthesising works of many great minds including the philosophers, Plato, Socrates and Aristotle and the mathematicians, Pythagoras, Descartes, Leibnitz, Euler, Fourier and Reimann. Not to forget another true genius written out of history and science, Viktor Schauberger. Only recently have I come across the works of Walter Russell, a lot of his work mirrors Schauberger, they would have been a formidable team.

Mindism presents an understanding that is a grand explanation of all things in the universe, although primarily relating to this planet, its application has to be universal.

Like the 'Tao Te Ching' by Lao Tzu, this work uses words to attempt to explain and describe that which is beyond words, i.e. the mental, non-dimensional realm of Soul and Mind.

## THE TWO CORE PRINCIPLES THAT THIS WORK CLARIFIES AND EXPLAINS ARE AS FOLLOWS:

There are three realms of existence that humans and other life forms constantly experience,
non-dimensional mind, 2) dimensional physical matter, and 3) the realm that separates the two.

2) DNA is the molecular structure that enabled life to manifest on this planet and evolve accordingly, it is the instrument that Mind uses to 'communicate' with matter. This occurs through 'portals' created by vortical fields that are generated within the physical, dimensional structure of the DNA molecule. The vortex creates a two-way flow of energy, (as seen in tornadoes and whirlwinds). Energy and information are often synonymous, representing the same 'thing'. This two-way flow, enabled Mind to communicate with certain physical molecular structures and receive information, [in the form of waveform frequencies] which it processed accordingly.

If you do not at least consider that your mind processes information, then maybe better to return to your video game, virtual reality. I am not intending to appear cynical. The Truth is not for everyone, so I read....

Life on this planet began more than three and a half billion years ago. already by then, Mind was an intelligent entity, evolving in the Non-Dimensional Realm of Existence outside the physical realm of SpaceTime 'matter'. Mind, as ever, did not and does not need a brain or any other physical structure to maintain its existence.

To understand the 'origin of species' it is first necessary to understand the origin of biological life on this planet. The evolution of species could only truly occur after the biological life processes that occur within the single cell became so efficient and adaptable that multicellular organisms were able to manifest and evolve.

This work is not intended to be a science lesson, maybe checkout on the internet and compare the difference between prokaryotic and eukaryotic cells. The former predate the latter. They are much smaller and their DNA is free floating within the cell. Eukaryotic cells have their DNA encapsulated inside the 'nucleus' of the cell and are much larger and hence more complex. Increased complexity and versatility are what should be expected from a more evolved system.

Single cell organisms were able to evolve because the intelligence that operated the decision-making processes was already well established long before any of the primal factors that together enabled living organisms to appear on this planet. That is to say that Mind and the intelligence inherent within it, had been evolving for billions of years before planet Earth came into existence.

Life was able to manifest on this planet because the intelligence that operated the decision making processes was already well established long before it existed. That is to say that Mind, and the intelligence inherent within it, had been evolving for billions of years before planet Earth came into existence.

Improving efficiency and saving energy and surviving in a hostile environment are basic concepts that drove the decision-making process that manifested within Intelligent Mind. Intelligence became inherent in the evolving Mind. It was not there immediately after the Big Bang, it arose from the interaction of the Waveform Frequencies that emanated from the 'source'. The 'source' as defined by Leibnitz is the Monad. He used that term, a Greek word, however, unofficially, he used the term, Soul. It was this Intelligence, that designed the manipulation of the physical structure of the cell wall and the internal structures of the cell and that enabled the life processes to continue and evolve.

The manipulation of the physical environment of the cell was at the level of the molecules and atoms that the physical structure of the cell comprised of. Ultimately, these physical structures are composites of sub atomic particles which are themselves 'fields of energy'. Physical structures are made up of these subtle energies, this needs to be taken into account, it needs for you to mentally digest that concept as best you can because that is the level that Mind operated on in its ability to modify, design and control molecular structures and affect how they interacted with other molecular structures.

It is at this level of subtle energies that one can visualise how a primitive *multicellular* structures such as Hydras, were able to learn to tell the difference between various molecules passing through their 'digestive' tube. They needed to block entrance to destructive forces/molecules, [toxins] and allow and encourage the absorption of beneficial forces/molecules, [nutrients].

In order to understand Mindism it is necessary to recognise that the speed of movement of some of these molecules and forces is often immensely fast. One thousandth of a second can be a long time in the life of a cell and hundreds of life processes/biochemical reactions can occur within the cell during that one thousandth of a second. It is an immensely complex and ordered environment, however, that was not the situation of the primal cells that appeared around four billion years ago. The number of biochemical reactions, along with other cellular activities, has slowly increased over a huge time period. These processes evolve and are controlled by algorithms generated by the Creative Intelligent Design inherent in Mind.

I use the term biological life to refer to the scientific definition of life, whereby organisms have to be able to sustain and reproduce themselves accordingly. (That Planet Earth itself may be alive requires a broader and somewhat different definition of 'life' to be used). For the whole of this work, I use the term 'life' to refer to biological life.

It is now well established that evolution did not occur through random mutation and that many mutations themselves are 'generated by the DNA molecules themselves'. Mindism asserts that DNA does not 'self-mutate', rather it is the inherent intelligent design that generates the subtle change in sequence of DNA molecules as a response to changes in the physical environment.

A basic premise of 'Mindism' is that (according to available data), biological life only arises on this planet where there are molecules of DNA. No DNA, no Life. On other planets it is feasible that other elements such as Silicon, enable Mind to connect and communicate with physical 'matter'.

The individual atoms of carbon, hydrogen, nitrogen and oxygen that combine to form the basic structure of a DNA molecule, are not known for their high IQ's or their ability to make critical analysis of 'germ theory'. The intelligent mind that can make informed and real-time decisions is a separate entity, albeit connected to, a biological organism. Mind connects to the cell through the DNA at the centre of the cell.

All multicellular organisms including plants, start their life journey as a single cell (a germ cell), which subsequently divides and differentiates into the various organs that enable that organism to maintain its own life processes. Although outwardly looking very different from other species, internally the cellular activity occurring within the organisms is often quite similar. Humans have some genes identical to the pea, ultimately, I am not a supporter of the conventional scientific explanations concerning genes and their expression, however, the facts have to be accepted (it is their interpretation that varies) and there are sequences of DNA found in human chromosomes that are identical and code for specific proteins that are found in humans and the pea plant.

It should be kept in mind that sequencing the human genome found fewer genes in the human than are found in the drosophila fruit fly, and that the meagre number of less than 22,000 genes in the human genome does not easily explain the appearance of over 200,000 different proteins found in the human body.

So, something is incorrect with the conventional scientific explanations. This work is a not a direct challenge to the 'scientifically' established explanation of life and its origins, it is more of a "filling in the gaps" type of thing. Actually, science does not put forward an explanation of how life started, Mindism does. The Evolution of Mind in the chapter Abiogenesis gives a rational and reasonable explanation of that process. A most easy to understand and meaningful interpretation and explanation of the facts and information available to us all.

Mindism dismisses the idea that DNA came from another planet and started life here. Were that the case, then the original life forms would not have been rudimentary primal cells that slowly evolved more complex structures and life forms taking billions of years to achieve this. Instead, they would have been more robust and more evolved from the start.

Mindism dismisses the idea that life has developed through random mutation over billions of years. Many structures within single cell organisms require more than one 'mutation' to occur at the same time in order for that structure to originally manifest. The bacteria flagellum is sounded as the proof that Darwinian evolution by random mutation is a false concept. Some use this as a reason to support the idea that the intelligent creative design is God himself, others suggest that God was female. Those who grasp the mere basics of Mindism realise that male and female only appeared more than two and a half billion years after the first lifeforms manifested. Cell bodies and primal multicellular bodies are neither male or female, *Mind is neither male nor female*, *however*, *physical bodies are*. Sexual differentiation arose as a means of increasing genetic variation and diversity, sexual differentiation was a creation of intelligent design. It is in the math....

Mindism does not accept the story of 'God' as given to us in 'ancient texts'. There is no empirical or sensory data that supports this story, neither is there any math to support it. The 'God' story is an interesting phenomenon that highlights the delicate nature of the human psyche and its ability to be manipulated and controlled by individuals of less inscrutable morals and ethics. Mindism does accept the concept of God as the Ultimate State of Mind that manifests with the extinguishing of SpaceTime and the disappearance of the zero-point field.

According to the Oxford dictionary, Belief, is to accept something to be true without any verification. Small children have to believe what adults tell them, they have to build up a store of information, before they can start using it to develop ideas of their own. I admit that that is a simple statement which is basically true, however, several other factors come into childhood mental development, this is not the place for me to discuss such matters.

Mindism does accept that it is Mind that manifests a hyper intelligent force of 'information processing', that itself has evolved, developed and enhanced its inherent intelligence. Mind exists in a realm/domain outside SpaceTime, it is a 'hyper' concept. Its existence is known by its attributes such as the ability to store and access information (memory) and the ability to process information from the most basic to the most complex. The concept of 'consciousness' arose relatively recently in evolutionary terms and developed accordingly. It is not a 'First Cause'. Mind is 'known' because, as humans, we know that we have some form of existence, even if we are unsure of its permanence.

First Causes are by definition (G. Leibnitz) the original existents, and all of existence manifests from this 'Source'. This is not my idea, but it is the foundation that enables an explanation of everything, it is from one of the greatest geniuses of all time, Leibnitz. Using his calculus, Euler gave us the mathematical proof of reincarnation. Apply rationale, reason and logic to a set of ideas and comprehension of the subject matter develops. Further the process and understanding evolves accordingly. As soon as there is a mental block introduced into this processing of information the mind becomes partially closed (down). Accepting things to be true that are not true (belief) is a block and disturbs and distorts the mind's ability to process information, accordingly.

So, as you wade through the information contained in this work and others on my website, strive to maintain the 'open mind' and question yourself as to why you believe that certain pieces of text are wrong.
